EMERGENCY DECLARATION

November 30, 2024

WHEREAS, Over the last 24 hours, Millcreek Township has experienced a severe snowstorm that has caused widespread road closures, trees & wires down, and power outages and;

WHEREAS, significant snow fall is expected to continue for several days, and temperatures are predicted to remain near or below freezing for several days as well;

WHEREAS, the existing conditions and predicted conditions pose a clear and present danger to life or property, including dangerous travel conditions for residents and emergency responders; and

WHEREAS, although the Township has initially responded to these events, the Township has concluded that the snowstorm is of sufficient severity and magnitude to warrant a this Emergency Declaration;

NOW, THEREFORE, at the direction of the Board of Supervisors of Millcreek Township; as Emergency Management Director, I declare a snow and ice emergency under Section 137-33 of the Millcreek Township Code in accordance with the following:

- 1. Under this Emergency Declaration, it is unlawful, at any time during the continuance of the emergency, for any person to park a motor vehicle or to allow that vehicle to remain parked anywhere on any snow emergency route designated pursuant to this article; or to drive any motor vehicle on any such snow emergency route unless that vehicle is equipped with snow tires or chains.
- 2. The following roadways are identified by Ordinance as emergency routes in Millcreek Township:

- 3. This Emergency Declaration shall be enforced by the Police Department, the Animal Resource-Code Enforcement Officer and any other any other designated Code Enforcement personnel.
- 4. If, at any time during a period of snow emergency declared under this article, a person shall park a motor vehicle or allow a motor vehicle to remain parked anywhere upon a snow emergency route, that person shall be guilty of a violation of the Millcreek Code and will be subject to the applicable penalties. If, at any time during a period of snow emergency declared under this article, a person shall drive a motor vehicle upon a snow emergency route without having that vehicle equipped with snow tires or chains, that person shall be guilty of a violation of the Millcreek Code and will be subject to the applicable penalties
- 5. This declaration shall stay in place until Wednesday December 4th, 2024, at 8am.
